Why Buy a Yacht with Other Owners?

- **Right to repurchase in 10 years:** Repurchase your share within 10 years at the purchase price plus an additional 5%.
- **Mandatory sale after 5 years:** You can recover your investment through a mandatory sale of your share after 5 years.





How Much Time Do I Get to Sail?

- **5 weeks per year:** Access to 5 vacation weeks—2 in the Balearic Islands and 3 in the Canary Islands, totaling 35 days of sailing.
- **Flexible options if you can't sail:** You can sell or gift your days, or have Seaduction Yachts market them for you.
- **Rental options:** Rent your weeks directly or through Seaduction Yachts, and receive rental income minus commissions.
- **Date flexibility:** Request date changes in advance, subject to availability.

Additional Destinations Beyond Canary and Balearic Islands:

- Each year we plan new destinations like Seville (April Fair), Marbella, the French Riviera, Corsica, Sardinia, Amalfi Coast, Sicily, Greece, Montenegro, Croatia, and Malta.
